Re: Request for Voluntary Compliance with Michigan Governor Executive Order 2020-69

Dear Ms. Huff,

Please be advised that the Ottawa County Prosecutor's Office has received a complaint that your business is open and operating contrary to Michigan Governor Executive Order 2020-69 (GEO 2020-69). The Michigan Attorney General has directed that all such complaints be investigated by local law enforcement agencies. It is my understanding that the Holland Department of Public Safety has been in contact with you prior to your opening the business and the writing of this letter. You have informed them of your intention to open your business, and have in fact done so, despite their request that you voluntarily comply with GEO 2020-69.

Please review GEO 2020-69 to determine if your business meets the criteria to be considered "essential" under that order. If you seek further clarification of what is stated in the order, please also review the Frequently Asked Questions pages found on the Attorney General's website at Michigan.gov/ag/.

Should you choose to close your business voluntarily; no further action will be taken. If you believe that you are operating in compliance with the order, you are encouraged to provide any information you wish to have considered by this office. If it appears that your continued operation is in violation of the order, a criminal citation may be issued, or in the alternative, a report will be forwarded to the Ottawa County Prosecutor and/or the Michigan Attorney General's Office for review and possible criminal and/or civil action.

You should be aware that consistent with Michigan Compiled Laws 10.33 and 30.405(3) that a willful violation of GEO 2020-69 is a criminal misdemeanor punishable by 90 days in jail and/or a \$500.00 fine.
