## PROVISIONS CONCERNING APPROPRIATIONS

**GENERAL SECTIONS**

Sec. 201. Pursuant to section 30 of article IX of the state constitution of 1963, total state spending from state sources under part 1 for the fiscal year ending September 30, 2021 is \$0.00 and total state spending from state sources to be paid to local units of government is \$0.00.

Sec. 202. The appropriations made and expenditures authorized under this part and part 1 and the departments, commissions, boards, offices, and programs for which appropriations are made under this part and part 1, are subject to the management and budget act, 1984 PA 431, MCL 18.1101 to 18.1594.

**DEPARTMENT OF LABOR AND ECONOMIC OPPORTUNITY**

Sec. 301. (1) As used in this section:

(a) "Applicant" means an internet service provider, governmental entity, educational institution, federally recognized tribe, or public-private partnership that submits an application for a grant after collaborating with the community in the unserved area.

(b) "Broadband service" means a retail service, not including a satellite service, capable of delivering high-speed internet access at speeds of at least 100 megabits per second downstream and 10 megabits per second upstream. Broadband service does not include mobile phone service.

(c) "Deployed" means that a provider meets either of the following:

(i) Currently provides broadband service of at least 100 megabits per second download and 10 megabits per second upload in



1 the specific geographic area of the proposed project of the  
2 applicant.

3 (ii) Is able to provide broadband service of at least 100  
4 megabits per second download and 10 megabits per second upload in a  
5 specific geographic area of the proposed project of the applicant  
6 to a customer that requests that service not later than 30 days  
7 after the customer requests installation of that service and  
8 without an extraordinary commitment of resources or construction  
9 charges or fees exceeding an ordinary service activation fee. The  
10 30-day time period is extended to 60 days if permits are needed  
11 before the broadband service is activated.

12 (d) "Internet service provider" means any of the following:

13 (i) An entity holding a license under the Michigan  
14 telecommunications act, 1991 PA 179, MCL 484.2101 to 484.2603.

15 (ii) An entity holding a franchise under the uniform video  
16 services local franchise act, 2006 PA 480, MCL 484.3301 to  
17 484.3315.

18 (iii) An entity currently providing broadband service in this  
19 state.

20 (iv) A political subdivision of this state.

21 (e) "MDLEO" means the department of labor and economic  
22 opportunity.

23 (f) "Person" includes an individual, community organization,  
24 cooperative association, corporation, federally recognized Indian  
25 tribe, limited liability company, nonprofit corporation,  
26 partnership, or political subdivision of this state.

27 (g) "Trade secrets" means trade secret as that term is defined  
28 in section 2 of the uniform trade secrets act, 1998 PA 448, MCL  
29 445.1902.



1 (h) "Unserved area" means any of the following:

2 (i) A census block lacking access to broadband service from at  
3 least 3 internet service providers.

4 (ii) An area lacking access to broadband service from at least  
5 3 internet service providers according to the most accurate and  
6 granular data on the broadband map created by the Federal  
7 Communications Commission.

8 (iii) An area delineated by the MDLEO by the process established  
9 in subsection (16).

10 (iv) An area without broadband service at a speed of at least  
11 100 Mbps downstream and 10 Mbps upstream.

12 (2) From the funds appropriated in part 1 for statewide  
13 broadband, the MDLEO shall maintain a statewide broadband grant  
14 program called the connecting Michigan communities broadband grant  
15 program within 60 days of enactment. Money for the program must be  
16 provided by appropriation of state or federal funding as provided  
17 by law and managed by the MDLEO.

18 (3) The MDLEO shall only use money from the grant program to  
19 award grants to applicants for projects that exclusively extend  
20 broadband service into unserved areas in this state and for the  
21 MDLEO's costs to administer the program.

22 (4) The MDLEO may award grant money to a governmental entity  
23 or educational institution or an affiliate or a public/private  
24 partnership, to own, purchase, construct, operate, or maintain a  
25 communications network, or to provide service to any residential or  
26 commercial premises.

27 (5) The MDLEO shall not, as a condition of an award of grant  
28 money, impose an open network architecture requirement, rate  
29 regulation, or other term or condition of service that differs from



1 the applicant's terms or conditions of service in its other service  
2 areas.

3 (6) The MDLEO shall not award more than \$15,000,000.00 to any  
4 1 project or to any 1 applicant. The MDLEO shall award initial  
5 grant money within 270 days after the money is made available under  
6 this program.

7 (7) An award of funds must be issued by a competitive grant  
8 process. The grant process must be technology neutral, and result  
9 in awards to applicants proposing projects based on objective and  
10 efficient procedures. The criteria for determining the award of  
11 funds must include the following:

12 (a) The applicant's experience and financial wherewithal.

13 (b) The readiness to build, operate, and maintain the project.

14 (c) The long-term viability of the project.

15 (d) The scalability of the network.

16 (e) The applicant's ability to leverage broadband for  
17 community and economic development.

18 (f) The applicant's ability to provide discounted broadband  
19 service throughout the unserved area to low-income households.

20 (8) Priority must be given to projects that demonstrate  
21 collaboration to achieve community investment and economic  
22 development goals of the area impacted, and that are able to  
23 demonstrate that they have the managerial, financial, and technical  
24 ability to build, operate, and manage a broadband network.

25 (9) Within 30 days after receiving an appropriation or federal  
26 funding to implement this section, the MDLEO shall establish and  
27 publish on the MDLEO's website the criteria for competitively  
28 scoring applications. Within 60 days after the MDLEO publishes the  
29 criteria, applicants shall submit their applications for funding of



1 their proposed project.

2 (10) An applicant for a grant under this section shall provide  
3 the following information on the application:

4 (a) The location of the project in the unserved area described  
5 by either the specific street addresses to be served or a shapefile  
6 as that term is defined in 47 USC 641.

7 (b) The kind and amount of broadband infrastructure to be  
8 purchased for the project.

9 (c) Evidence regarding the unserved nature of the community in  
10 which the project is to be located.

11 (d) The number of households that will have access to  
12 broadband service as a result of the project, or whose internet  
13 access service will be upgraded to broadband service as a result of  
14 the project.

15 (e) The significant community institutions that will benefit  
16 from the proposed project.

17 (f) Evidence of community support for the project with a  
18 narrative on the impact that the investment will have on community  
19 and economic development efforts in the area.

20 (g) The total cost of the project and a detailed budget and  
21 schedule for the project.

22 (h) All sources of funding or in-kind contributions for the  
23 project in addition to any grant award.

24 (i) The applicant's experience and financial wherewithal.

25 (j) The program outline of the digital literacy program that  
26 will be provided in the area to be served by the broadband  
27 services.

28 (11) The applicant's trade secrets, financial information, and  
29 proprietary information submitted under this section as part of an





1 application are exempt from disclosure under the freedom of  
2 information act, 1976 PA 442, MCL 15.231 to 15.246.

3 (12) After scoring and considering all grant applications, the  
4 MDLEO shall make grant award recommendations. The MDLEO shall give  
5 priority in making grant award recommendations to applications that  
6 demonstrate 1 or more of the following:

7 (a) Collaboration to achieve community investment and economic  
8 development goals of an impacted area.

9 (b) The applicant has the managerial, financial, and technical  
10 ability to build, operate, and manage a broadband network.

11 (c) The likelihood that the unserved area will not be served  
12 without state grant funding.

13 (d) The project will serve a larger unserved area or a greater  
14 number of locations within an unserved area than other proposed  
15 applications.

16 (e) The ability of the applicant to commit to providing at  
17 least 50% of the cost to deploy the project set forth in the  
18 application.

19 (f) The capability to deliver future-proof speeds up to and  
20 exceeding 1 gigabit per second downstream and upstream with no  
21 limitations on data utilization.

22 (13) Within 30 days after the award recommendations have been  
23 made, the MDLEO shall publish on its website the grant  
24 applications, redacted according to section 14 of the freedom of  
25 information act, 1976 PA 442, MCL 15.244, the proposed geographic  
26 broadband service area, and the proposed broadband service speeds  
27 for each application that receives an award recommendation.

28 (14) Before granting an award to an applicant, the MDLEO shall  
29 establish a period of at least 60 days after the date the award



1 recommendations are published on the MDLEO website, during which  
2 time the MDLEO shall accept comments or objections concerning each  
3 application. The MDLEO shall consider all comments or objections  
4 received, and investigate them as needed, in deciding whether an  
5 applicant is eligible for a grant. If an objection submitted by a  
6 provider contains information that requires an investigation and  
7 the objection is found to be inaccurate, the provider shall  
8 reimburse the MDLEO for the cost of verifying the information.

9 (15) The MDLEO shall not award a grant to an applicant if  
10 verifiable information is made available that shows any of the  
11 following:

12 (a) The proposed project includes an area where at least 3  
13 providers have deployed broadband service.

14 (b) The MDLEO receives a sworn statement from an officer of an  
15 internet service provider that the proposed project includes an  
16 area where construction of a network to provide broadband service  
17 is underway, and the construction is scheduled to be completed  
18 within 1 year after the date of the application.

19 (c) The MDLEO receives a sworn statement from an officer of an  
20 internet service provider that the proposed project includes either  
21 of the following:

22 (i) A specific geographical area where an internet service  
23 provider has been selected to receive, provisionally or otherwise,  
24 funding by the Federal Communications Commission or the United  
25 States Department of Agriculture specifically for the expansion of  
26 broadband services. This subparagraph does not apply to an area  
27 once either of the following has occurred:

28 (A) The internet service provider does not complete the  
29 requirements for obtaining the funding described in this



1 subparagraph.

2 (B) The time period for the internet service provider to  
3 receive the funding described in this subparagraph has expired.

4 (ii) An area where the construction of a network to provide  
5 broadband service is to be completed no later than 2 years after  
6 the date of an application.

7 (16) As part of an application under this section, an  
8 applicant may request that the MDLEO specifically delineate an area  
9 within a census block as being an unserved area. To tentatively  
10 establish an unserved area within a census block, an applicant must  
11 attest to both of the following:

12 (a) The delineated area within the census block is unserved  
13 and does not have access to broadband service.

14 (b) The delineated area is not within a census block that has  
15 been selected to receive, provisionally or otherwise, funding to  
16 support the expansion of broadband networks from the Federal  
17 Communications Commission or the United States Department of  
18 Agriculture.

19 (17) If a delineated area within a census block is tentatively  
20 determined by the MDLEO to be an unserved area, the recommended  
21 grant award for the application is still subject to a challenge by  
22 internet service providers under subsections (14) and (15).

23 (18) At the time a grant is awarded to an applicant, the MDLEO  
24 shall immediately provide notice on its website of each application  
25 receiving a grant, including the name of the entity, the amount of  
26 money being received, the broadband speed, and the unserved area  
27 for which the applicant is receiving the grant.

28 (19) The MDLEO shall require an applicant awarded a grant to  
29 submit a semiannual report from the time the applicant receives the



1 grant to 3 years after completion of the project. The semiannual  
2 reports must be made available on the MDLEO's website with any  
3 proprietary information redacted. The reports must be in a format  
4 specified by the MDLEO and give an accounting by the applicant of  
5 the use of the money received and the progress toward fulfilling  
6 the objectives for which the money was granted, including all of  
7 the following:

8 (a) The number and location of residences and businesses that  
9 will have access to the broadband service.

10 (b) The speed of broadband service.

11 (c) The average price of broadband service.

12 (d) The broadband service adoption rates.

13 (20) A person that files a false statement under this section  
14 is ineligible to receive a grant under this section the next time  
15 grants are issued after filing that false statement.

16 (21) If an applicant is found to be noncompliant with the  
17 grant commitments after 3 years, the applicant will forfeit grant  
18 funding in an amount proportional to the number of residences and  
19 businesses in the award area that remain unserved.
