

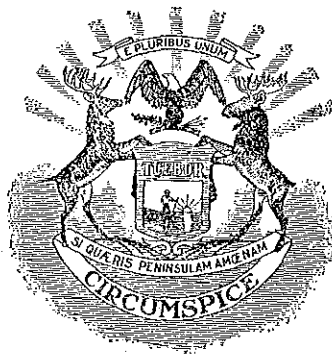

## JOINT RESOLUTION, 1923

[No. 1.]

A JOINT RESOLUTION proposing an amendment to article eight of the state constitution by adding thereto a new section to stand as section thirty, authorizing the legislature to provide for the incorporation of ports and port districts with power to engage in work of internal improvements.

*Resolved by the House of Representatives and the Senate of the State of Michigan,* That the following amendment to article eight of the constitution of this state, by adding a new section thereto to stand as section thirty of said article, is hereby proposed, agreed to and submitted to the people of this state, that is to say, that a new section be added to said article eight to stand as section thirty and to read as follows:

SECTION 30. The legislature may provide for the incorporation of ports and port districts, and confer power and authority upon them to engage in work of internal improvements in connection therewith.

*Resolved further,* That the foregoing proposed amendment be submitted to the people of this state at the election to be held in the month of April in the year nineteen hundred twenty-three. The secretary of state is hereby required to certify said proposed amendment to the clerks of the various counties of the state in the manner required by law. It shall be the duty of the board of election commissioners of each county to prepare ballots for the use of the electors when voting on said proposed amendment, which ballot after setting forth the proposed amendment in full shall be in substantially the following form:

"Vote on amendment to article eight of the state constitution, by adding a new section thereto to stand as section thirty of said article. Shall article eight of the state constitution be amended by adding a new section thereto to stand as section thirty of said article, authorizing the legislature to provide for the incorporation of ports and port districts with power to engage in work of internal improvements?

AMENDMENT TO THE CONSTITUTION.

Amendment to the constitution authorizing the legislature to provide for the incorporation of ports and port districts with power to engage in work of internal improvements in connection therewith, proposed by the legislature of nineteen hundred and twenty-three, and ratified by the people at the biennial spring election on Monday, April 2, 1923.

## ARTICLE VIII.

SEC. 30. The legislature may provide for the incorporation of ports and port districts, and confer power and authority upon them to engage in work of internal improvements in connection therewith.
